# The right dose.

Behavioral health is important.

If your child has attention deficit hyperactivity disorder (ADHD), his or her provider may suggest medication. There are several kinds of medicines that treat ADHD. It may take a while to find the best medicine for your child.

Your child may need to change medicines or dosages a few times. Some medicines may not help your child. Others may cause side effects. A dose may be too low or too high.


That's why it's important for children on ADHD medicine to see their doctors often. Go within 30 days of when your child starts taking medicine. Visit again twice in the following nine months.

Then, be sure to keep regular appointments. Behavioral therapy and counseling are also important and should be tried before medication in children under age 6.

Getting treatment for substance use can help you have a better life. Help for you or someone you love can start by talking with a doctor, nurse or counselor. Here's how to start your recovery:



- Take an active role. Keep your appointments. Ask questions.
- Find the right program. Different kinds of help are available. Make sure the program feels right for you.
- Get help from your family and friends. Don't try to get better by yourself. Having people you can turn to for support and advice can help.
- Add a support group. Talking with others who have "been there" is very helpful. There are many types of online and in-person groups.

## Oh, baby!

Did you know that without prenatal care, babies are 3 times more likely to be born too small?

If you are pregnant, it's important to get early and regular prenatal care. It can help keep you and your baby healthy. You will get your weight, blood pressure and urine checked at each visit. You will listen to your baby's heartbeat. You will have tests to diagnose problems early.

Start seeing your provider as soon as you are pregnant. Have your first visit before your 12th week. Then, go monthly for the first 6 months. Go every 2 weeks for months 7 and 8. For the last month, see your provider every week.

# Grow up strong.

It's important to have well-child visits with your child's primary care provider (PCP) on time. These visits may also be called checkups or Early and Periodic Screening, Diagnostic and Treatment (EPSDT) visits. Take your baby for well-child visits at the following ages:

- 3 to 5 days.
- 1 month.
- 2 months.
- 4 months.
- 6 months.
- 9 months.
- 12 months.
- 15 months. • 18 months.
- 24 months.

Then, take your child or teen to his or her PCP every year. At wellchild visits, your child's PCP will make sure your child is growing and developing well. Your child will get any tests and vaccines he or she needs. The PCP will answer your questions about your child's health.

# Your best shot.

### Immunizations keep kids healthy.

Years ago, many children died from common diseases. Today, those diseases are rare. This is because children now get vaccines to keep them from getting sick. It's important for all children, from babies through teens, to get the right shots at the right time.

Shots for babies (birth-15 months)

- HepB: Hepatitis B (3 doses).
- Hep A: Hepatitis A (2 doses).
- DTaP: Diphtheria, tetanus, pertussis (4 doses).
- Hib: Haemophilus influenzae type b (3-4 doses).
- IPV: Polio (3 doses).
- PCV: Pneumococcal (4 doses).
- RV: Rotavirus (2–3 doses).
- MMR: Measles, mumps, rubella (1 dose).
- Varicella: Chickenpox (1 dose).
- Influenza (yearly).

Booster shots for young children (4-6 years)

- DTaP: Diphtheria, tetanus, pertussis.
- IPV: Polio.
- MMR: Measles, mumps, rubella.
- Varicella: Chickenpox.
- Influenza (yearly).

Shots for pre-teens (11-12 years)

- Tdap: Tetanus, diphtheria, pertussis.
- HPV: Human papillomavirus (3 doses).
- MCV: Meningococcal.
- Influenza (yearly).
- HepA: Hepatitis A (only if at high risk).





**Keep track.** Keep a record of what shots your child gets and when. Share this list with any new providers you see. Make copies of this list so you can give them to child care, schools, camps or sports programs.



# Checkup time.

Well visits keep track of growth and development.

School-age children and teens need to see the doctor once a year for a checkup. This visit is sometimes called a well-child visit or an Early and Periodic Screening, Diagnostic and Treatment (EPSDT) visit. Checkups help make sure your child is growing strong and healthy. At this visit, the doctor will:

- Check your child's height, weight and body mass index (BMI).
- Give your child any immunizations he or she
- Talk to your child about important health and safety topics for his or her age.
- Make sure your child is developing well.

## Know your BMI.

In the United States, more than 2 out of 3 adults are overweight or obese. Obesity is also becoming more common in children. Nearly 1 out of 5 children are obese according to recent data. Being overweight or obese puts you at risk for many problems. These include heart disease, high blood pressure and type 2 diabetes.

Are you too heavy? Know your body mass index (BMI). This figure tells you if your weight is too high for your height.

- 18.5 to 24.9 is a healthy weight.
- 25 to 29.9 is overweight.
- 30 or higher is obese.



**Know your** number. Your doctor can tell you what your

BMI is, or you can enter your weight and height to find out your BMI at cdc.gov/ healthyweight/assessing/bmi.

# Controlling asthma.

### Take steps to limit attacks.

Asthma is a disease that affects the lungs and airways. It causes serious coughing and wheezing. Children and adults with asthma can get help from their doctor. Medication can help control daily symptoms.

Sometimes, even with medication, a person can have a severe asthma attack. A bad attack makes it difficult to breathe. This could become an emergency.

To control your asthma, learn what can trigger an attack.

- Exercise. Some people only have attacks after vigorous physical activity.
- Airborne irritants. Things in the air, such as pollen, dust mites, smoke or pet dander.
- Cold or dry air.
- Catching a common cold or the flu.

Develop an asthma action plan. Talk to your doctor about the best way to prevent or manage attacks. You might need to add quick-relief medications or use an inhaler.

### Q: Why does my child need to be tested for lead?

A: Lead is often found in plumbing or paint in older homes. It can also be found in painted toys made outside of the United States. Because babies and toddlers often put their hands and toys in their mouths, they can swallow lead. They can also inhale it.

When lead gets into the body, it can end up in the blood, bones or organs. Too much lead in a child's body leads to lead poisoning. It can result in slow growth or developmental problems.

Many children with lead poisoning don't have symptoms. That's why testing is important. Experts recommend testing at ages 1 and 2. Lead testing is part of a checkup at these ages. The test is done using a few drops of blood.

## What to expect.

It's easy for a new mom to neglect her own health. But it's very important to see your doctor or midwife 6 weeks after you give birth. If you had a Cesarean section, you should also go 2 weeks after you give birth. At your postpartum checkup, your provider will:

- Check to make sure you are healing well from childbirth.
- Screen you for postpartum depression.
- Do a pelvic exam.
- Let you know if you are ready to start having sex again.
- Talk about birth control options.
- Answer questions about breastfeeding and examine your breasts.

# **Getting the** right care.

Where to go for the care you need.

Choosing the right place to go when you are sick or hurt can help you be seen faster. It is important to choose a primary care provider (PCP). Make an appointment to see your PCP before you have an urgent need.

See your PCP whenever possible. Your PCP has easy access to your records, knows the bigger picture of your health and may even offer same-day appointments to meet your needs. You may want to see your PCP for needs or symptoms such as:

• Skin rash.

- Flu shot.
- Minor injuries.
- Earache.

If you cannot get in to see your PCP, you can go to an urgent care center. Urgent care centers take walk-in patients. You may want to go to urgent care for:

- Cough or cold.
- Stomach pain.
- Fever or sore throat.
- Minor cuts or burns.

Emergency rooms are for medical emergencies only. Go there only when you think your illness or injury could result in death or disability if not treated right away.

For general health questions, call Member Services, 24 hours a day, 7 days a week. Experienced registered nurses can give you information and answer questions about:

- Choosing where to get medical care.
- Finding a doctor or hospital.
- Health and wellness help.
- Medicine questions.
